

## The Prime Minister of Malaysia lectures on The Challenge of Good Governance in the Muslim World



Tun Dr Mahathir Mohamad

On 24 September Tun Dr Mahathir Mohamad, Prime Minister of Malaysia, lectured at the Centre on 'The Challenge of Good Governance in the Muslim World'. A long-standing friend and supporter of the Centre, it was Dr Mahathir's sixth visit and second Distinguished Lecture (the first being in 1996). It was also his first major lecture in the West since returning as Prime Minister last May. The lecture, held in the Malaysia Auditorium, was attended by senior members of the University and representatives from many diplomatic missions. The talk was also video-streamed into two other lecture spaces to accommodate all those wishing to attend.

In his lecture, Dr Mahathir provided an historical overview of governance in Islamic countries. He noted that democracy has developed in Western countries over centuries and it was unrealistic to expect that Muslim countries can adopt it overnight. The strength of a democratic system rests on the appreciation within the electorate of the importance of universal suffrage. Each vote counts and hence every voter has an individual responsibility to participate in the electoral process. Societies need time and patience to transition from feudal and traditional rule to systems of governance based on participation and accountability. Overthrowing one system does not immediately lead to the successful establishment of another. Following the lecture, Dr Mahathir answered questions on the impact of technology (including social media) on politics, the interaction of customs with religion and the importance of knowledge exchange and educational links between countries.

The vote of thanks was proposed by Mr Richard Graham MP, the Prime Minister's Trade Envoy to ASEAN and Chairman of the Westminster Foundation for Democracy.

# Centre's Academic Progress Reviewed International Links Reinforced

The International Academic Advisory Committee met in May to discuss the Centre's academic priorities as it settles into its new premises. On this occasion, the Committee reviewed the development of Centre's visiting fellowship programmes, scholarship schemes for students, research, and publication projects. Possibilities of further international partnerships with foundations, universities, and other academic institutions were explored. The remit of the committee is to set the Centre's academic work and programmes in an international context and to assist the Centre in developing its international outreach. An important focus is the promotion of dialogue and cooperation betwen scholars from different academic and cultural traditions.

### Centre launches School **Educational Visits** Programme

The Centre launched its School Educational Visits Programme in February 2018. The programme provides an enriching out-of-classroom learning experience for children who are studying Islam as part of the Religious Education curriculum. Teachers and students are given a guided tour of the Centre's buildings, gardens, and the Mosque. This is followed by an interactive presentation on Islamic faith and civilization tailored to the specific curriculum objectives of a visiting group. Ms Caroline O'Connor, a qualified and experienced local teacher, leads this programme in consultation with the Centre's Imam, Mr Ibrahim Amin.

The programme continues to grow in popularity and several local and regional schools, both primary and secondary, have already benefitted from it.

It aims to create a multi-discilinary, multisector and intergenerational platform for collaboration.

## Young Leaders meet at the Centre Annual Leadership Programme

The thirteenth annual Young Muslim Leadership Programme (a joint initiative of the Centre and The Prince's Charities) was held in early July. The programme brings together 25 British Muslims aged between 21 and 30 to Oxford for an intensive residential leadership course. This year's cohort included participants who work in the civil service, medicine, the charity sector, consultancy, law, business, teaching and a local councillor. and senior academics enjoyed an expert survey of the challenges facing the region. In a substantial question and answer session, many questions focussed on the region's unresolved conflicts, notably in Syria and Libya, and relationships in the Gulf, notably with Iran. Concern was also expressed to promote progress on Palestine, and avert humanitarian crisis in Gaza, concerns which Mr Burt said the Government fully shared. The Minister was also asked about the implications of wider international engagement in the region, particularly by the United States and Russia and the role of Europe, as well as the practical benefits of bringing together the political and development portfolios for the region.

The participants attended lectures, seminars and workshops led by a variety of speakers from all parts of public life. Guest speakers included Ms Layla Moran MP, Baroness Chakrabarti, Sir Ciaran Devane (Chief Executive of The British Council) and Imran Madden (Chief Executive of the Islamic Relief), and Alexander Desforges (Press Secretary to the Archbishop of Westminster). The 2018 cohort now join an active network of 250 YMLP alumni.

## Joint conference with the Atlantic Council Human Rights and the Islamic tradition

In May, the Atlantic Council's Rafik Hariri Centre held a conference jointly with the Centre on the subject of Islam, Human Rights and Muslim Communities. The one-day conference took place as part of a larger Carnegie Endowment funded project and engaged religious scholars ('ulama), academics and practitioners for a frank private, discussion on the relationship between the Universal Declaration of Human Rights and the Islamic tradition. The theme of 'theoretical considerations' noted Islam's own historical tradition of acknowledging human dignity in terms of "duties" or "responsibilities" rather than "rights" and that the Islamic perspective could enrich the global conversation on human rights. A second theme revolved around practical challenges including women's rights and the role of Islam in modern medicine. The final theme looked at regional cases – different perspectives included the Malaysian experience and the rise of Islamophobia in the United States.

# International Forum on Peace in Revealed Religions

In May the Centre hosted a two-day forum, in partnership with the Muslim World League (Makkah), exploring the value of peace in Abrahamic faiths, as part of its commitment to improve understanding between different cultural, religious, and intellectual traditions. The forum opened with a session in which eminent scholars and faith leaders from various faith traditions outlined frameworks from

their specific faith perspectives for *Abda* positive inter- and intra-faith tolerance and peace between and among religious adherents. It was followed by three plenary sessions dedicated to eliciting a deeper understanding from a diverse range of faith perspectives regarding peace, tolerance and

good society.

The Centre was pleased to welcome many senior participants including: HE Dr Mohammad ibn Abdulkarim Al-Issa (Secretary General of the Muslim World League); HE Shaikh Abdallah Bin Bayyah (President of the Forum for Promoting Peace
